

International Conference "Industrial Parks for Inclusive and Sustainable Industrial Development" 11-12 June 2019 National Association of Industries (SNI) Lima, Peru

In recent decades, industrial parks have made important contributions to the restructuring and development of the global economy, generating jobs and increasing incomes. Industrial parks offer a structured institutional framework, integrated services and a physical infrastructure that may not be available outside them.

When industrial parks are properly planned and operated, they offer the opportunity to address the three dimensions of sustainable development: social equity, economic growth and environmental protection, in line with the SDGs, particularly SDG9. The key factors for successful industrial parks are multiple and require a solid legal framework and long-term government commitment, which create an attractive environment for the business sector.

At the same time, a strong association of the private, public and financial sectors is required; a viable business model for each park under consideration, an inclusive and forward-looking planning and a management of industrial parks based on the dialogue between the multiple parties involved. In addition to promoting industrial development, industrial parks promote innovation and encourage the application and development of new technologies and innovative concepts.

The International Conference on "Industrial Parks for Inclusive and Sustainable Industrial Development" will be organized jointly by UNIDO, the Ministry of Production of Peru and the National Association of Industries (SNI) of Peru. It will bring together and present a wide range of international knowledge and experiences on different aspects of industrial parks, including government policies, financial tools, private sector initiatives, eco-industrial parks, circular economy business practices and industry applications 4.0. In addition, critical cross-cutting issues for social inclusion in industrial parks will be addressed, such as gender empowerment and the creation of jobs for young people.

The Conference will be organized within the framework of the Programme for Country Partnership (PCP) - Peru, which is implemented by the Ministry of Production and UNIDO since the beginning of 2018. The PCP Peru seeks to accelerate inclusive and sustainable industrial development and builds in a multi-stakeholder partnership led by the Ministry of Production.

In this context, the development of the National Strategy on Industrial Parks in Peru is a key milestone in this fruitful cooperation exercise, and will show that Peru is committed to developing a solid regulatory framework and policies on the subject, with the consequent favorable impact, in addition to those already mentioned in the preceding paragraphs, in terms of attraction of investments.

The Conference will also serve to facilitate the exchange of know-how and experience on industrial parks and on the future vision of industry in 2030 and its alignment with the SDGs, in particular SDG 9.
